

## ROAD MAP

The graphical representation, called the Road Map, indicates some of the key steps that need to be taken to improve the legal status and access to labour market and education for various migrant categories identified in mixed migration flows facing the Republic of Serbia for almost a decade.

All the proposals displayed in the graphical representation are based on case analyses, practical experience and outcome documents of the “Road Map for Migrants – Guide through the Labyrinth” Project. The graphical representation and the conducted analysis match in time with the announced amendments to key laws in the fields of asylum and treatment and employment of foreigners, and some of the suggested solutions rely on the proposed amendments to the applicable legislative framework of Serbia.

	RIGHT TO EDUCATION	Amendments to the legislative framework	<ol style="list-style-type: none"> <li>During the forthcoming implementation of the Strategy for Development of Education in Serbia by 2030, and in line with the set impact indicator for achieving a general goal: <i>Increased quality of teaching and learning, fairness and availability of primary and secondary education and enhanced upbringing role of educational institutions</i>, it is necessary to further develop and define support measures for inclusion of refugee and migrant children in the educational system, while they are staying in Serbia, including the measures aimed at increasing the number of these children in secondary schools.</li> <li>Expecting the new 2022 Annual Plan for Adult Education and for the purpose of including migrants as a specific group of adults into the educational system, the measures facilitating access to the Functional Migrant Adult Education Programme need to be defined in detail.</li> </ol>
